a. Discussion and Presentation with Stifel regarding DMFD use of Certificates of Participation to fund PSPRS Pension liabilities.

- a. Monthly Run Report Chief Wilson

- b. Prop 207 Revenue Ch Maxwell Chief Maxwell reported that we received our first funding amount from Prop 207. The funds are distributed bi-annually at the end of June and the end of December. There are projections could be around \$150k for Daisy Mountain Fire Department each year.
